**Eastern Region Youth Development Program** – Please go to the [www.erusars.org](http://www.erusars.org) web page and go to the contest page to see our current rules and requirements. The current singles music is also there to be downloaded. **We have purchased the special sanction for skaters to compete in the unofficial events. USA Roller Sports Amateur Cards will not be necessary.**

**Eastern Region Intro Events -**

- An open event for skaters who have never competed in an official Level A, B or C event at the Regional Championships in that artistic event.

- Skaters who exceed the skill level of Intro will be asked to register in Level C, B or A Standard divisions in future competitions.

- Skaters in the Intro Events will receive a special medallion signifying placement or participation in the Tri-State Championship.

- All Intro events will be skated as a final event only.

- There will be three age groups as follows: (Age as of 1/1/2016)

Tiny Tot Intro – 6 & under (Figures, Freestyle, Solo Dance, No Team Dance)

Primary Intro – 7 & 8 years old (Figures, Freestyle, Solo Dance, No Team Dance)

Youth Intro – 9 to 15 years old (Figures, Freestyle, Solo Dance, Team Dance)

Adult Intro - 16 years old and older (Figures, Freestyle, Solo Dance, Team Dance)

Figure Requirements: 111A & 112B

Dance Requirements: Glide Waltz & Progressive Tango

Intro Free Skating Rules:

Time: Maximum of two minutes (+/- 5 seconds)

Music: Any music may be used, including vocal, as long as content is deemed appropriate.

Content: Maximum of 5 jumps. Half or single jumps only. May only include one combination jump, which will count as one jump.

Maximum of 3 upright spins. May only include one combination spin, which will count as one spin. No camel or sit spins.

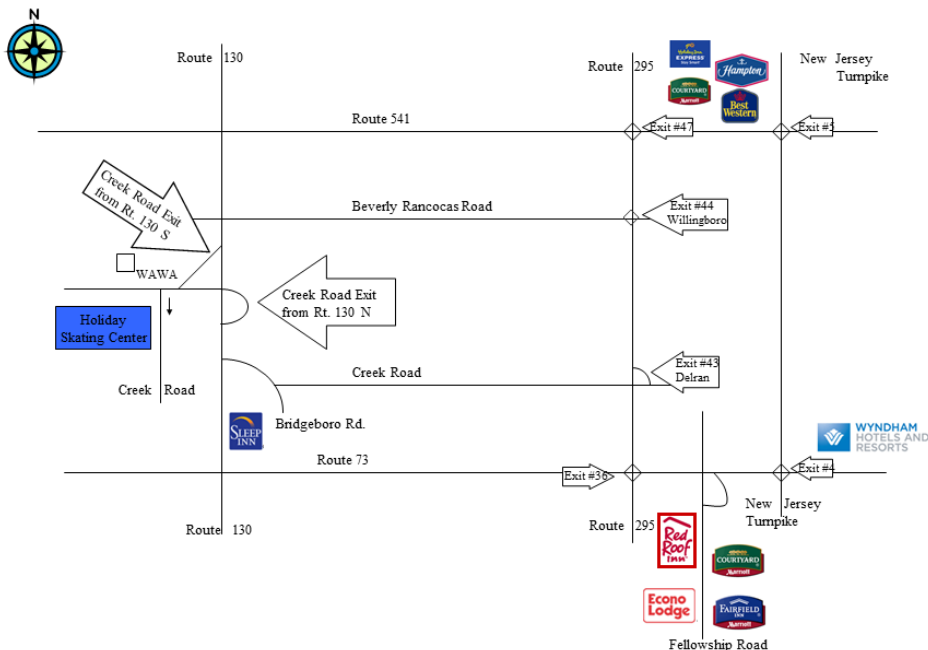

### MAP AND DIRECTIONS



#### FROM THE:

- North - NJ Turnpike South to Exit 6 (PA Turnpike Extension Exit), Exit off of the extension before getting into PA on the Rt. 130 South Exit. Follow Rt. 130 South to Creek Road exit. (about 4 miles, exit is at a WAWA Store) Make a right at the end of the exit and a quick left at the next street. The skating center is on the right ¼ mile down the road.
- West - PA Turnpike across bridge into New Jersey. Get off at the first exit after the bridge onto Rt. 130 South. Follow Rt. 130 South to Creek Road exit. (about 4 miles, exit is at a WAWA Store) Make a right at the end of the exit and a quick left at the next street. The skating center is on the right ¼ mile down the road.
- South- NJ Turnpike North to Exit 4, Rt. 73 North to Rt. 130 North, Rt. 130 North to Delanco (about 4 or 5 miles) to Creek Road Jug Handle Exit. Follow Creek Rd. after exiting Rt. 130 - Turn left at first street (about 300 yards) - The skating center is on the right ¼ mile down the road.

If you are using a GPS navigation system or Map Quest.com to get to the skating center the address is 1775 Creek Road, Edgewater Park, NJ. Our mailing address is Delanco, NJ but there is another Creek Road in Delanco and it will take you to the wrong Creek Road. (Our parking lot is in Edgewater Park.)

**USARS SPORT PARTICIPANT WAIVER & RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND/OR PARENTAL CONSENT AND INDEMNITY AGREEMENT**

I, \_\_\_\_\_, the undersigned, do hereby affirm and acknowledge that I have been informed of the inherent hazards and risks associated with the sport of roller skating, transportation of equipment related to the activities, and traveling to and from activity sites in which I am about to engage. I further agree to abide by the rules and regulations of USARS during the terms of this registration and agree to observe the Amateur Code of Conduct, in spirit as well as in letter, upholding the high ethics of amateur roller skating. I agree that I will wear the protective gear that is required by USARS.

I understand that dangers may be caused by my own actions, or inactions, the action or inaction of others participating in these activities. I understand the nature of USARS' activities and believe that I (or my minor child) am/are qualified and physically fit to participate in roller skating competitions and practices. I further acknowledge that I am aware that activity will be conducted in facilities that may be open to the public. As a skater, parent or legal guardian, I further agree and warrant that prior to participating in any event I will inspect the facilities to be used and if believing conditions are unsafe, I will immediately advise my coach or the host of this condition and refuse to participate unless corrected.

I fully understand that USARS' activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death, and economic losses which might result not only from a skater's action, inaction or negligence, but the action, inaction or negligence of others, the rules of competition, or the condition of the premises or any equipment in use. I fully accept and assume all such risks and responsibilities for losses and costs and damages incurred as a result of my participation in USARS activities or arising out of my traveling to or returning from such activities or practice sessions.

I hereby release, discharge, covenant not to sue and agree to hold harmless with respect to any and all injury, disability, death or loss of damage to persons or property, caused or alleged to be caused in whole or part by their negligence, the following persons or entities:
